New Tax Law

Effective January 1, 2016 all Habitat for Humanity affiliates in the State of South Carolina became exempt from paying sales tax on construction materials used to build or rehabilitate a Habitat home. This will reduce the cost of the mortgages for our future home owners by a few thousand dollars. If you run into Thomas Alexander our South Carolina State Senator or William Sandifer III our South Carolina State Representative please thank them for their support with this bill.

Goal for 2016

I recently had a discussion with the Executive Director of all the South Carolina Habitat for Humanity affiliates. He is a huge fan of our business model and wanted us to make a presentation to other affiliates next week at the annual conference in Columbia on how to operate an all volunteer HFH organization. We decided to pass on this opportunity but it make me reflect on the things that make us special. First and foremost is our army of volunteers (200+) that make a difference every day in every facet of our operation. In addition we are a low cost charitable organization. Our primary expenses are the costs associated with running our Resale Store and with building houses (our reason for being). Most of the other affiliates in South Carolina have paid staff so they are not nearly as efficient with their donations and Resale Store revenue as we are. This leads me to our next strength which is an excellent balance sheet that enables us to build houses and fulfill the HFH mission. Finally we have been blessed by having our OCHFH founders and the leaders over the last 30 years develop and fine tune a model that works. There is an old saying that goes "if it ain't broke, don't fix it". So with that said the goal for 2016 is simple.....provide more houses for Oconee County families in need of a quality place to live.
